RISK ACKNOWLEDGMENT AND ACCEPTANCE FORM

Acting as guardian of the child(ren), as part of the ski lessons provided by the Le Relais ski school, I acknowledge and accept the following:

1. ACKNOWLEDGMENT OF RISKS and ACCEPTANCE:

The signatory and the participant acknowledge that practicing a board sport involves inherent risks regardless of the level of supervision of the instructor and the level of skill of the student, of which they must be aware, accept the risks and assume full liability for any material or bodily damage resulting from said risks. Among other things, and without limitation, the following elements constitute risks inherent to the practice of a board sport:

- Changing climatic conditions;
- Changes in the degree of slope inclination;
- The presence of natural obstacles and the condition of the mountain. Any natural condition of the mountain, such as the presence of pits, crevices and streams, the presence of rocks, earth, spaces not covered with snow, the presence of trees, tree regrowth, natural shrubs and stumps, as well as any other natural obstacle;
- The presence of ice and patches of ice;
- Any change to the conditions of the skiable surface;
- Any collision with another skier or any other person;
- The presence of pylons, poles and other structures used in the operation of the station as well as the collision with these elements;
- The use of ski lifts;
- The presence on the slopes of mobile slope maintenance equipment, emergency vehicles, as well as snowmaking equipment.

For an enriching and safe experience, you must respect the Mountain Code of Conduct at all times and show courtesy to others. You must obey all other rules and signs posted or otherwise indicated by the Resort. Be vigilant and follow the code. It's your responsibility!

2. STUDENT RESPONSIBILITY:

It is the student's responsibility to respect the instructions and put into practice the lessons received from the instructor; It is the student's responsibility to respect the signs and act safely;

3. RESPONSIBILITY OF THE PARENT/GUARDIAN/RESPONSIBLE OR PARTICIPANT:

The parent/guardian/responsible or participant is responsible for ensuring that the student's ski or snowboard equipment is adequate, safe, in good condition and checked regularly;

Wearing a helmet is strongly recommended by the snow school;

The parent/guardian/responsible or participant is responsible for disclosing to the school and instructor any pre-existing medical conditions of the student that may impact skiing/snowboarding and its inherent risks;

The parent/guardian/caregiver or participant is responsible for being punctual at the start of each lesson. In this case, lost time will not be recovered.

4. SUPERVISION:

I recognize that skiing/snowboarding is practiced over a large area, which means that the instructor is not near his student(s) at all times, nor can he intervene directly at all times; the instructor cannot have visual contact with his/her student(s) at any time;

5. SLIDER LESSONS:

In the context of a sliding lesson, the instructor's attention is divided between the students, and the instructor cannot focus his attention on a particular student at any time;

As part of a skiing lesson, the student may be required to use the ski lifts without the presence of their instructor in the same chair (boarding coordination);

6. REGULATIONS:

This contract is subject to the laws in force in Quebec. The signatory as well as the issuer agree to elect judicial domicile in Quebec, in the judicial district of the ski resort and choose this as the exclusive forum for any claim, whatever it may be, arising from this contract.

7. CANCELLATION POLICY:

Private lessons

- Cancellation free of charge 24 hours in advance, otherwise an administrative fee of \$40 will be charged.
- If the station is closed due to bad weather we will contact you to issue a refund or move your course to a later date.

If the course card is lost, a new card will be issued at a cost of \$10 (taxes included)
